



Important Tax Notice to U.S. Investors Who Are U.S. Taxpayers

This statement is provided to shareholders who are United States persons for purposes of the U.S. Internal Revenue Code of 1986, as amended (“IRC”) and the regulations thereunder. It is not relevant to other shareholders.

Manulife Global Balanced Private Trust (the “Fund”) may be deemed to be classified as a Passive Foreign Investment Company (“PFIC”) as defined in Section 1297(a) of the IRC for the year ending December 31, 2018 and thus, its securityholders are shareholders of the PFIC.

We recommend that all U.S. taxpayer clients consult a tax advisor concerning the overall tax consequences of their ownership of securities of the Fund and their U.S. tax reporting requirements. You can also find information on U.S. tax rules applicable to investments in a PFIC on the IRS website, www.irs.gov, by searching “Form 8621 Instructions”.

Please find below a PFIC Annual Information Statement (“AIS”) for the Fund. The PFIC AIS is being provided pursuant to the requirements of Treasury Regulation §1.1295-1(g)(1). The PFIC AIS contains information to enable you, should you so choose based on the advice of your tax advisor in light of your personal tax circumstances, to elect to treat the Fund as a qualified electing fund (“QEF”).

Generally, an election is filed for each mutual fund for which you wish to make a QEF election. If you hold securities of the Fund and the Fund holds securities of one or more underlying mutual funds, you will receive a combined PFIC AIS containing information that will enable you to elect to treat any or all of the funds as a QEF as you choose, as well as information relating to your securities and values in your indirect holdings.

Note that the information attached with this letter is intended to help you make one or more QEF elections, if you decide to do so, and neither such information nor this letter constitutes tax advice. The taxpayer should seek advice based on their particular circumstances from an independent tax advisor.

1) This Information Statement applies to the taxable year of the Fund for the year beginning January 1, 2018 and ending on December 31, 2018.

2) Your pro-rata per share amounts of ordinary earnings and net capital gains for each Series of the Fund for the period specified in paragraph (1) are as follows:

- i. If you owned the same number of securities from January 1, 2018 through December 31, 2018, multiply the number of such securities by the amounts above.
- ii. If you did not own the same number of securities from January 1, 2018 through December 31, 2018, multiply the number of securities you owned by the amounts above as well as by the number of days the securities were held in 2018 and divide the result by 365.

Example 1: On January 1, 2018, you acquired 10,000 units of Advisor Series which earned \$0.042911 ordinary earnings per unit and \$0.087101 net capital gains per unit, and held them throughout the year. Your pro-rata share of Advisor Series' ordinary earnings and net capital gains would be US\$429.11 (i.e., 10,000 units x \$0.042911) and US\$871.01 (i.e., 10,000 units x \$0.087101) respectively.

Example 2: On July 1, 2018, you acquired 10,000 units of Series C which earned \$0.082990 ordinary earnings per unit, and \$0.163409 net capital gains per unit, and held them throughout the remainder of the year (184 days). Your pro rata share of Series C's ordinary earnings and net capital gains per unit would be US\$418.36 (i.e., 10,000 units x \$0.082990 x 184/365) and US\$823.76 (i.e., 10,000 units x \$0.163409 x 184/365) respectively.

Example 3: On August 1, 2018, you acquired another 2,000 units of Advisor Series in addition to the 10,000 units in example 1 and held 12,000 units for the remainder of the year, (153 days). Your total pro-rata share of Advisor Series' ordinary earnings would be US\$465.08 (\$429.11 + (2,000 units x \$0.042911 x 153/365)). Your total pro-rata share of Advisor Series' net capital gains would be US\$944.03 (\$871.01 + (2,000 units x \$0.087101 x 153/365)).

 - ii. If you did not own same number of securities from January 1, 2018 through December 31, 2018, multiply the number of securities you owned by the amounts above as well by the number of days the securities were held in 2018 and divide the result by 365.
- 4) Please note that for reporting purposes you may need to separately report your pro-rata share of income and pro-rata distribution of cash and property distribution from the Fund and for each underlying fund.
