I think I would have received more emotional support growing up. 00:00:47 I was often home alone while my mom was working, my brothers were studying or working. 00:00:50 In my early teens, I harbored a lot of anger and I bottled up my emotions which was very unhealthy. 00:00:56 I wish I had spent more time with family, or at the very least go through therapy or someone to talk to.
